The SSO Program- a review

One step toward making Baton Rouge America's next great city!

The Sanitary Sewer Overflow (SSO) Program is the vehicle by which the City of Baton Rouge/East Baton Rouge Parish (C-P) will meet the requirements of their Consent Decree, a mandate issued in 2001 by the federal government to reduce SSOs. SSOs occur when sewage leaves the system without treatment, which occurs most frequently during wet weather.

The SSO Program is constructing 110 projects to come into compliance with the Consent Decree:

- 58 projects are complete (nearly \$600 million construction value)
- 30 projects are under construction (over \$430 million construction value)
- 22 projects are in design (over \$230 million construction value)

These projects will upgrade and rehabilitate the system by increasing the system's capacity and fixing defects so that it can effectively serve the parish's 445,000+ residents. Once all projects are complete, the wastewater system will have nearly 2,000 miles of separate gravity and pressure sewer systems and more than 400 pump stations.




